RESOLUTION AUTHORIZING THE AMENDMENT OF THE TUBAC FIRE DISTRICT’S BOUNDARIES TO INCLUDE LAND WITHIN SANTA CRUZ COUNTY AND CONTIGUOUS TO THE BOUNDARIES OF THE TUBAC FIRE DISTRICT AT THE WRITTEN REQUEST OF THE PROPERTY OWNER IN ACCORDANCE WITH A.R.S. § 48-262(I).

WHEREAS, \_\_\_\_\_ *(Name(s))* requested, in writing, that the Board of Directors of the Tubac Fire District amend the Tubac Fire District boundaries to include property owned by the requesting person(s), which real property is more particularly described as set forth on the attached Exhibit A; and

WHEREAS, the subject property is located within Santa Cruz County and is contiguous to the boundaries of the Tubac Fire District as shown on the map attached as Exhibit B; and

WHEREAS, the Tubac Fire District Board has determined that the inclusion of the subject property within the boundaries of Tubac Fire District will benefit the Tubac Fire District and the property owner.

NOW THEREFORE, BE IT RESOLVED that the Board of Directors of the Tubac Fire District hereby orders that the boundaries of Tubac Fire District are hereby amended to include the subject property described as set forth on the attached Exhibit A; and

RESOLVED, FURTHER that the District staff is authorized and directed to record a certified copy of this Resolution with the County Recorder of Santa Cruz County, Arizona, which will make final the boundary change to include the subject property.
