The Tubac Fire District Board of Directors will meet in regular session on March 29, 2023, at 1:30 pm. The Board may consider any item on this agenda in any order and at any time during the meeting. The Governing Board may convene into Executive Session for discussion or consultation for legal advice with its attorney regarding any item on this agenda, in accordance with A.R.S. § 38-431.03(A)(3).
